### Shipped Semen Breeding Contract

I hereby agree on this \_\_\_\_\_ day to breed the mare \_\_\_\_\_ with registration number \_\_\_\_\_ to the stallion Commandalena AQHA 3223538 for the 2016 breeding season.

The stallion fee is **\$2,000.00** and there is no booking fee upon execution of the contract. **Contract paperwork can be sent to: Dana Grafft at 18711 Paprika Court in Germantown, MD 20874 or scanned in and emailed to [d.grafft@yahoo.com](mailto:d.grafft@yahoo.com). Payment can be made via check or cc (with 5% convenience fee added).**

A photo copy, both sides, of the registration papers on your mare must accompany this contract. The owner recorded on the registration papers will be the owner recorded on the stallion breeding report.

Third party collects stallion on Monday, Wednesday, and Fridays. No Exceptions! This is to preserve stallion fertility throughout our breeding season. Breeding season exists February 1st through July 15th.

This contract contains a 'Live Foal Guarantee'. A live foal is described as a newborn foal which stands and nurses without assistance. If a foal is born dead, or a mare absorbs/aborts a predetermined pregnancy there are return privileges, only if Dana Grafft (Reiners Rule, LLC), is notified within thirty (30) days and receives a statement confirming this. A 'Live Foal Guarantee' will apply only to those mares that are certified in foal by a licensed, attending veterinarian. Confirmation of such pregnancy in the form of documented ultrasound picture or letter from the attending veterinarian must be received by October 1 of the breeding year.

If the mare absorbs or aborts a pregnancy after having been checked in foal, or if the mare fails to conceive during normal breeding season, the Stallion Manager agrees to breed the same mare again during the immediately following year's breeding season. The same fore mentioned charges from Nandi Veterinarian Services apply. A substitute mare, accepted by Dana Grafft (Reiners Rule, LLC), may be used ONLY if the original mare is deceased or deemed unfit for breeding by a licensed, attending veterinarian.

A Breeders Certificate will be issued for the foal conceived as a result of the breeding. The Breeders Certificate will be issued only after all expenses have been paid in full and after the foal is born and reported to Dana Grafft (Reiners Rule, LLC).

Neither Dana Grafft (Reiners Rule, LLC) nor any of its officers or employees shall be liable for damages as a result of damage to the semen or as a result of a mare failing to settle.

Dana Grafft (Reiners Rule, LLC) sole liability under this contract is in the event the stallion should die or become unfit for breeding purposes, the Mare Owner will be provided frozen semen instead of fresh chilled semen collected previously by Nandi Veterinarian Associates.

When signed by both parties, this document will become a legally enforceable contract, binding both parties. The parties acknowledge that this agreement is made and shall be considered to be entirely performed within the State of Maryland and shall be construed and enforced under the laws of the State of Maryland Law, an equine professional is not liable for an injury or death of a participant in equine activities resulting from the inherent risk of equine activities.

### **Cooled, Frozen & Fresh Semen**

A request for a shipment of cooled and frozen transported semen must be made at least 24 hours prior to the shipping time. Mare Owner is responsible for \$150 veterinarian collection fee, \$35 disposable shipping box fee and overnight FedEx from New Freedom, PA, to final destination.

Shipping cancellation must be made by 8:30 am (Eastern Time) of the shipping day. Failure to cancel by 8:30 am will result in a \$150 collection charge. Cancellations can be made by phone (301.785.0952). Cooled semen will only be sent via FedEx, Mare Owner must provide a credit card to Nandi Veterinarian Associates for above mentioned collection expenses

Frozen semen shipped outside the United States, depending on country, may require additional fees (ex: USDA Permit, additional packaging, different courier service, etc.), Nandi Veterinarian Associates
